The **Paris Lodron-University Salzburg**

invites applications for a permanent position

as

Full Professor in European Union Law

Faculty of Law (Department of Public, International and European Union Law) and the **Salzburg Centre of European Union Studies**

starting 1 October 2021.

The candidates are expected to be able and willing to undertake research and teaching across the entire range of EU law and have their principal research focus on either or both institutional or substantive areas of EU law. Furthermore, candidates must be able and willing to teach all EU law courses in the diploma program as well as in both interdisciplinary programs "Law and Economics" and "European Union Studies", to participate in all examinations held in these programs, to supervise academic work in the area of EU law and to participate in the Salzburg Centre of European Union Studies (SCEUS).

General requirements include:

1. academic education and a PhD/doctorate appropriate for the advertised position;
2. qualification to teach at the university level (*venia docendi*) or equivalent;
3. an outstanding research record;
4. suitable pedagogical and didactical skills;
5. managerial skills necessary to head a university institution;
6. proof of integration into the international scientific community (e.g. active in peer-review processes, pertinent experience abroad, etc.);
7. advanced fluency in both written and spoken English;
8. upper intermediate level of written and spoken German or the willingness to achieve this within two years.

Additionally, it is expected that there is:

1. a willingness to participate in and expand the research and teaching partnerships of the Paris Lodron-University;
2. a willingness to participate in university committees and self-government bodies of the University;
3. active participation in the Salzburg Centre of European Union Studies (SCEUS);
4. to that end, being frequently physically present at the university;
5. experience in modern scientific management
6. previous successes in the acquisition of third-party funding,

7. team spirit and social skills;
8. willingness and qualification to take over managerial positions;
9. experience in interdisciplinary research and/or interdisciplinary teaching as well as a willingness to cooperate with the two other disciplines represented at SCEUS, i.e. political science and economics.

The University appoints professors full-time on a tenured contract according to the regulations of the Austrian Universities Act, the Angestelltengesetz and the Kollektivvertrag for university employees (group A1 / <https://www.uni-salzburg.at/index.php?id=31062>). The basis of salary negotiations is the required legal minimum of €5.245,60 before taxes (in 14 monthly payments).

The University of Salzburg is looking to increase the proportion of women in its staff and therefore invites qualified female applicants to apply. In cases involving candidates with equal qualifications, women are given priority.

Persons with disabilities or chronic illnesses who meet the required qualification criteria are expressly invited to apply.

Unfortunately, any travel and accommodation expenses incurred during the admission procedure cannot be reimbursed.
